COMMISSIONER VACANCY ANNOUNCEMENT

Riverbank Housing Authority Commission

Applications are currently being accepted to fill a Tenant Commissioner and a Commissioner at Large seat for Riverbank Housing Authority. Both seats are an unpaid, volunteer positions and no specialized experience is required.

Eligibility to Apply:

- **Tenant Commissioner:** The applicant must be a current tenant of the Authority's housing units in the City of Riverbank. If a tenant member ceases to be a tenant of the Housing Authority, he/she shall be disqualified from serving as a Commissioner. The over 62 age requirement for this seat does not apply.
- **Commissioner at Large:** The applicant must be a current resident of the City of Riverbank. If the Commissioner at large ceases to be a resident of the City of Riverbank, he/she shall be disqualified from serving as a Commissioner.

General Information: The Authority owns and operates units of Low Rent Public Housing and administers grant programs for the Modernization of Low Rent Public Housing units. The Housing Authority of the City of Riverbank is governed by a seven (7) member Board of Commissioners, two of which are tenants, and one such tenant member is required to be over the age of 62. The Housing Authority Commission meets on the second Thursday of every other month at 8:00 a.m., at the Riverbank Housing Authority Office located at 3309 Stanislaus Street.

Selection Process: Submission of a completed application is required. Interviews of the Applicants may be conducted. All applicants will be notified of the status of their application. Appointment to the Commissioner seat is made by the Mayor of the City of Riverbank, which is subject to the confirmation of a majority of the members of the City Council.

- Recruitment opens: June 12, 2018 and will remain opened until filled; applications will be reviewed as received.
