RECOMMENDATION

Following review and discussion, staff recommends the Commission approve the execution of an agreement with the State of California Employment Development Department.

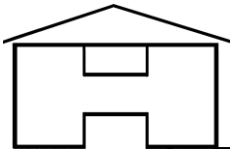
BACKGROUND

The Employment Development Department (EDD) provides confidential employer address, wage and unemployment and disability insurance payment information to the Housing Authority. The Agency agrees to use the confidential information provided by EDD for the purpose of verifying applicants and tenants eligibility for and continued entitlement to housing assistance in accordance with Title 42, United States Code, Section 3544. The State of California Employment Development Department requires a Board Resolution to enter into the contract for services.

DISCUSSION

The Housing Authority is required to obtain third party verification of income and employment status. With this Agreement the Employment Development Department agrees to provide confidential employer address, wage, and unemployment and disability insurance payment information to the Housing Authority. This information is a valuable tool to verifying applicants and tenants eligibility for, and continued participation in housing assistance programs. This Agreement is a renewal of services we have utilized through the Employment Development Department for the past several years which has proven to be an efficient and reliable source of required information.

RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE STATE OF CALIFORNIA EMPLOYMENT DEVELOPMENT DEPARTMENT

WHEREAS, the Housing Authority of the County of Stanislaus desires to enter into an agreement with the State of California Employment Development Department; and

WHEREAS, the Housing Authority is required to obtain third party verification of applicants and tenants eligibility for and continued participation in housing assistance programs; and

WHEREAS, the Employment Development Department agrees to provide the necessary confidential verification, as required; and

WHEREAS, the Employment Development Department requires a Board Resolution to enter into such agreement;

NOW, THEREFORE BE RESOLVED by the Board of Commissioners of the Housing Authority of the County of Stanislaus, that:

1. The agreement between the Authority and the State of California Employment Development Department to provide confidential third party verification of applicants and tenants eligibility for continued participation in housing assistance programs has been approved, and
2. The Request for Contract Renewal between the Housing Authority and the State of California Employment Development Department is attached as Exhibit A.
3. The Executive Director is hereby authorized and directed to take any and all actions, and to execute the agreement, and
4. This resolution shall take effect immediately.
