Housing Authority County of Stanislaus DBA Stanislaus Regional Housing Authority Housing Choice Voucher Program Wait List Opening - Limited

The Housing Authority of the County of Stanislaus (HACS) DBA the Stanislaus Regional Housing Authority announces the opening of the waiting list for the Housing Choice Voucher Program (HCV) for applicants who qualify for the following Local Wait List Preferences - "Mainstream Voucher Program Applicants" and "Applicants "moving-up" from Stanislaus County Permanent Supportive Housing Programs funded through the local Continuum of Care. The wait list will remain open for these applicants until further notice.

IMPORTANT INFORMATION FOR INTERESTED APPLICANTS:

Only those applicants who are determined income eligible and eligible for these local preferences and will be admitted to the wait list. This wait list opening limitation is in accordance with HUD PIH Notice 2012-34.

The definition of the "Mainstream Voucher Program" Local Wait List Preference is as follows:

Applicant families who have a non-elderly disabled person between the ages of 18-62 in the household and who meet the following conditions:

- transitioning out of institutional and other segregated settings; or
- at serious risk of institutionalization; or
- currently experiencing homelessness; or
- previously experienced homelessness and currently a client in a permanent supportive housing or rapid rehousing project; or
- at risk of experiencing homelessness

Applicants for the Mainstream Voucher Program must be currently on the County of Stanislaus Coordinated Entry System waiting list and submit a Coordinated Entry Placement Verification Form when applying for the Mainstream Voucher Program. This Local Wait List Preference is limited to the current number of Mainstream Vouchers allocated to the Housing Authority. Applicants who are currently on the HACS's HCV wait list and qualify for this Local Preference can contact the HACS to update their application.

The definition of the "Applicants "moving-up" from a Stanislaus County Permanent Supportive Housing Program funded through the local Continuum of Care" Local Wait List Preference is as follows:

Applicant families participating in a Permanent Supportive Housing Program who are graduating from the program and certified as "graduating" from the support service agency providing the permanent supportive housing. A Permanent Supportive Housing Graduate Form must be submitted with the application. Applicants who are currently on the HACS HCV wait list and qualify for this local preference can contact the HACS to update their application.
